A volunteer group of medical, business, legal and addiction professionals supported by partnered organizations have established a private centre based on the original Crosbie Centre program model. The new Crosbie enjoys the diversity of old and new staff, a professional Board, strong community support and partnership with premiere corporations and institutions. The Society was created with the assistance of Martha Crosbie, widow of the founder and the Jack Crosbie Memorial Trust Fund. The original Crosbie Centre was closed in 2003 after 24 years of successful, abstinence based treatment programs.

Organization Profile

The Crosbie House Society is incorporated under the Societies Act of Nova Scotia (Registry #3087978) and is a registered charity (Business #85741 5806 RR0001) It operates on a fee-for-service basis without government subsidies. Consultation, assessment, referral services, supplementary assistance, family & community programs and seminars are provided at no cost to those needing help.

Four of the six permanent program staff came from the previous Crosbie Centre and collectively they have over 100 years of addiction counseling experience. They operate in a contemporary and progressive environment supported by contracted fitness, medical, spiritual and program specialists. The clients enjoy an abundance of first rate, dietitian endorsed, home cooked meals prepared by a professional full-time cook.

The Program

Crosbie House Society's primary purpose is to offer an effective abstinence based 12 step, 28 day residential addiction recovery program for alcohol, drug and gambling addictions. Crosbie has been successful in treating the sickest people. *Participants are treated as sick people coming to get well, not crazy or bad people who need to get sane or reform.*

The staff provides assessment, counseling, education, facilitation, rehabilitation and aftercare planning, mentoring and monitoring. The program makes full use of community resources, existing agencies, and self-help organizations in this process.
